Separated Mentality & Satanic Mentality

Be disciplined, watch, because your adversary, the Diabolical One, is a roaring lion walking about seeking someone he may devour; (1 Peter 5.8)

The Diabolical One is typically called Satan or the devil in most Christian writings. The terms devil or Satan have come down through the centuries from Hebrew, Greek, and Latin words. In the ancient Scriptures "Satan" is called the accuser or adversary.

Satan or the Diabolical Mind is the manifestation of all concepts and ideas that are against God Almighty. Satanic ideas are contrary to God because they cannot bring about any spiritual or created physical life. Satan can only mongrelize creation. Satanic ideas cause corruption. The satanic mentality destroys the order that God set forth at the beginning of His creation and what is called good.

The disorder caused by satanic thinking is insanity because it is in rebellion against God's order. When God's Word is corrupted it becomes a lie. When a lie is told, that is a murder of the truth. Satan placed himself as a god, and this was a lie. There is only one God and one Truth. Satan was thrown out of Heaven because God does not stand beside sin.

Now Satan and his demons were cast down to earth and imprisoned. They existed as disembodied spirits or mentalities and their insanity was the beginning of godless thought on earth. We can understand from this that everything exists somewhere whether spiritually or physically. Only God Who is the same as Christ Jesus has the power of creation or destruction. The Lake of Fire was made for the enemies of God and this is the second death where the spirit is destroyed.

Man is both physical and spiritual. His body is the physical expression. His mind is the spiritual expression. Our bodies can see things and feel things, etc., this is the physical realm. Thoughts however are in the spiritual realm. Words emanate from thoughts. Thoughts and ideas cannot be seen or heard, though it is by his thoughts that a man may affect his environment. Thinking leads to actions. Right thinking to right actions and wrong thinking to wrong actions. Satan is an insane mentality. He cannot cause a change in the physical world. His insane slaves must do it for him. These are those people who are devoted to corruption, evil, apathy, and willful ignorance. The insane satanic mentalities are what the Sons of God fight against today as they have from the

beginning. **Because we are not wrestling against flesh and blood, but against the rulers, against the authorities, against the world's rulers, against the darkness of this age, against the mentalities of evil in the heavens. (Ephesians 6.12)** However, do not think that spirits are flying around making you do evil. Christ has come and conquered sin and death, which is failure and spiritual death. A man is tempted by his own evil lusts. It is Jesus who makes a way for us to see the Truth, to see through the insanity. **No temptation has taken you except what is of man; but God is trustworthy, Who will not allow you to be tempted beyond what you are able, but will make with the temptation also a way out, for you to be able to bear it. (2 Corinthians 10.13)**

The world or the flesh is always at enmity with God. The flesh is physical and it will die, therefore it cannot grasp the things of the mentality or spirit. The flesh does not come under the favor of God. It is the mentality that is subject to the authority of God. Adamic man was created as a vessel and the Mentality of Christ must dwell within him so that he is a filled vessel. The body container is filled with the Separated Mentality. Without the abiding Mentality of Christ, the vessel is empty and it follows in the way of the world. It follows after its lusts instead of the Way of God. **But each one is tempted by his own lusts, being drawn out and being seduced, then lust, having conceived, gives birth to failure, and failure being fully formed, brings forth death. (Jacob 1.14,15)**

God affects the material world by His Separated Mentality or Holy Spirit. This is sanity and it permits spiritual life. God has set this in motion as the Baptism of Fire. This is a purification or the burning away of insane anti-Christ thoughts and ideas. People will choose to follow the Will of God and sanity to spiritual Life or they will enslave themselves to the satanic mind and be destroyed in the second death.

Now we will delve into how Satan planned to attack God by deceiving the Adamic race that God had called out as His portion of the earth. Satan believed he could defeat God by corrupting Adamic man because it is Adamic man who was made to house God's Mentality on earth. As has been already said, man is both physical and spiritual. The man is empty or dead spiritually unless he indwells the Holy Spirit, which is the Separated Mentality of Christ.

A man can be alive and walking around and still dead. We are speaking of the spiritually dead. This is the biblical definition of death. To be alive spiritually, to be sane a man

must have the Mentality of Christ abiding. The man who follows after the ways of the world is spiritually dead, he does not care for the spiritual way of God. The ones who follow the Mentality are spiritually alive. They are following the moral justice of Christ in their lives. He who is living according to the justice of Christ is at peace with God. The state of being at peace with God has nothing to do with the world. Peace with God is being in agreement with God. **For those according to flesh mind the things of the flesh; and those according to the Mentality, the things of the Mentality. For the minding of the flesh is death, but the minding of the Mentality is life and peace. Because of this, the minding of the flesh is enmity towards God, for it is not subject to the law of God, neither can it be. (Romans 8.5-7)**

Those who are not in agreement with God cannot please Him. When God inspects His vessel, there must be a piece of His Mentality there. God recognizes His own. If God looks into your inner mind and does not find His Word abiding there, then God does not recognize you as His vessel. When a man rejects God's truth he is in rebellion to the Eternal God. **And those being in the flesh are not able to please God. But you are not in the flesh but in the Mentality, since the Mentality of God dwells in you. But if anyone does not have the Mentality of the Anointed, this one is not His. (Romans 8.8-9)**

Christians who are alive with the Separated Mentality are dead to the world. We have rejected the insanity and anti-Christ behaviors, philosophies, and ideals. We follow the justice that the Word of God has given us. We act in the knowledge and wisdom that God teaches us. The truth of God sets us free from the lies and insanity of Satan. **But if the Anointed is in you, the body truly is dead because of failure, but the Mentality is life because of justice. But if the Mentality of the One having raised Jesus from the dead dwells in you, the One having raised the Anointed from the dead will make alive your mortal bodies also through the indwelling of His Mentality. (Romans 8.10,11)**

Satan's plan to corrupt Adamic kind was to introduce them to his insanity. This is rebellion against the truth of God. Satan, the adversary presents his sin as a freedom, his pride and arrogance that he was a god and for which reason he was cast out of Heaven. Satan tells the woman that she may acquire a special knowledge that would let the Adamics become like gods themselves. Satan as the father of lies tells the woman that she will not die as God has told her if she partakes of the tree of good and evil.

Disobeying God's commands is disloyalty. God's first spiritual law is to worship nothing before God. **You shall not have other gods besides me. (Exodus 20.3 LXX)**

This is Satan's plan to defeat God. Satan believes that if he corrupts the vessel- the Adamic race, then he will have defeated God. This is where the insanity of mongrelization comes in. Satan cannot create he can only mongrelize. Because he cannot create in his own right, Satan must replace God with worldly things. This is the satanic philosophy of the physical over the spiritual. Anything that replaces God in the mind of a man is an idol. Satan uses materialistic idolatry as a replacement for God. Not only is God's first spiritual law broken but this is also the gateway to mongrelization. Idolatry lifts up a person, animal, or thing to replace God. This exalts the creature over the Creator. This is the manifestation of the ungodly attributes of pride and arrogance, an insult to the Master Creator. This is the same sin that Satan was guilty of and the reason he was expelled from Heaven. **Because having known God, they did not repute Him as God, nor were they thankful, but became vain in their reasoning, and their undiscerning heart was darkened. Professing to be wise, they became foolish, and changed the reputation of the unmongrelizable God into a likeness of an image of a mongrelized man, and of birds, and fourfooted animals, and reptiles. Because of this, God gave them up to mongrelization in the lusts of their hearts, their bodies to be dishonored among themselves- who changed the truth of God into a lie, and worshiped and served the creature rather than the Creator, Who is blessed to the ages. So be it. (Romans 1.21-25)**

We can see from the Scripture that God's law does not only forbid the worship of worldly things but also of spiritual idolatry. Remember that the thoughts a man has always lead to his actions. Spiritual idolatry comes before physical idolatry or engaging in un-Christian behavior. Many people claim to be spiritual, many seek spiritual things but they do not seek the truth. God's Word is Truth. God's truth must be acted upon. **For not the hearers of the law are just with God, but the doers of the law will be justified. (Romans 2.13)**

Once a Christian has heard the truth of Christ why would he turn back to the lie? The Narrow Way is too much trouble for the Christ traitor. These spiritual traitors hate responsibility, which is living a Christian life. The broad way leading into Hell has plenty of whoredom, materialistic indulgence, and degeneracy. This is touted as freedom while a man's mentality is enslaved. Every day another link is added by idol worship and those chains pull him ever closer to the grave. Christ is freedom. Turning back to the

lies of the world is a return to your shackles. **But then truly, not knowing God, you served as slaves to the ones not by nature being gods; but not knowing God, but rather, being known by God, how do you turn again to the weak and poor element, to which again you desire to slave anew? You observe days and months and seasons and years. I fear for you, lest somehow I have labored among you in vain.**

(Galatians 4.8-11)

Jesus told us that Satan was the father of lies. He perverted the truth of God by mixing it with a lie. Satan lied to Eve in the Garden, leading her to believe that she would not die but gain knowledge to be like a god. Satan exalted the physical over the spiritual. Physical existence is only temporary. When the Adamics disobeyed God they died spiritually. Satan counted this as a great victory against the Almighty. Leaving out the spiritual side of God's order is a mongrelization of truth. Disobeying God has spiritual consequences. We can see here that Satan as an insane mongrelized mentality cannot understand the things of the spirit. This is why satanic thought can only perceive physical things.

Satan lied to Adam and Eve when he told them that they would not die for disobeying God. He told them a half-truth. A half-truth leads to a lie. A lie is an illusion, only truth is reality. A lie is a perversion of truth and truth is the language of Heaven. God's Separated Word is Truth and it is eternal. God's Truth is hated by the world, that is satan's slaves- in other words all liars and all who help make a lie. Satan lied to Adam and Eve mongrelizing the truth. Satan was the first to mongrelize the truth, and he is called the father of lies because of it.

Unfortunately, many people who would claim to be Christian do not speak in truth. When a person becomes Christian, they are like babes and must work and study Biblical Truth to grow into a full knowledge of the Master. To fail in one's growth, to wither and die through backsliding is to become a spiritual abortion. The Spirit of Truth, the Mentality of Christ is the teacher of truth. To become a mature Christian we must learn this truth and live by its teaching so we are not led to hell by half-truths and lies through satanic insanity. **Then stand firm in the freedom with which the Anointed made us free, and do not again be held with a yoke of slavery. (Galatians 5.1)**

Now Satan led the woman to believe that she could exalt herself as a god. The woman was told the lie that she would have the same knowledge as God. Next Satan slipped in another neat little lie. Satan told her that she would not die by death even though God

had said she would. This word death, in Greek θανάτω (*thanatō*), means death; mortality; death, pestilence causing death. This was spiritual death. The man and woman died spiritually the moment they disobeyed the Living God. The physical bodies of men and women were only temporary. Their perfect estate of mind and body in agreement with God was destroyed at that moment. Satan deceived them by leaving out the spiritual part and leading them to focus only on the physical. God's Word says that the physical will die, only the spirit may live, and only the spirit separated to God can have life and peace. This is eternal life and peace with Christ and not with the world. **For those according to flesh mind the things of the flesh; and those according to the Mentality, the things of the Mentality. For the minding of the flesh is death, but the minding of the Mentality is life and peace. (Romans 8.5,6)**

Satan purposely used his craft of deception to present the lie that physical and spiritual were the same. It was a perversion of reality, a mongrelization of the Adamic vessel. Satan presented himself as an authority on God's Word. He contradicted the divine commandment given to the Adamic man. These satanic tactics have not changed even today. Satanic insanity is still leading people to hell with deceptive half-truths and lies. To truly understand the fall of man found in Genesis we must work through some of the popular creation myths, lies, and half-truths that the satanic mentality has deceived many people with.

Two creation accounts?

There are various players in the world today who set themselves up as religious authorities. Be it Jews or their various tributary religions called Judeo-Christians (Catholics, Orthodox, or the various protestant groups), Christian Idenitists sects, and gnostic groups. In their assault on the Word of God many pervert the Book of Genesis by teaching that there are two creation accounts there. This is a deception introduced by the Judeo-insane comen to pervert the creations of God. Only by following the truth of the Word can we overcome these false religions.

The first account of Creation begins in **Genesis 1.26**; then as the insane believe, a second starts in **Genesis 2.7**. The problem introduced here is that having two different accounts of creation perverts the order that God set down in the beginning. Many of the people who preach this double creation myth teach the lie that the first account is the creation of non-Adamic people. They then go on to say that the second creation is the Adamic kind. The first problem this causes is that it gives non-Adamics a place over Adamics. This is unbiblical, the Scriptures declare that the Adamic creation is God's portion of the earth. Furthermore is the fact that Adamic man has the unique ability to house the Spirit or Mentality of God. Non-Adamic creation does not possess this trait. Any non-Adamic humanoids, be they of any original race, "neanderthals" or any type of hominoids in whatever form that God created and called good, are not "man". They are animals and belong to the creation of all other animals that God made. Classifying these non-Adamic humanoids as man is the cause of much confusion in theological circles. Many religionists would like to make "pre-Adamic peoples" as part of their fake history and insane religion. This only serves to lead good people down a path of lies.

We read about the beginning of Adam man in **Genesis 1.26 Then God said, "Let us make humankind according to our image and according to likeness, and let them rule...** Now the two-accountists who believe this verse is about non-Adamics must also believe that the non-Adamics were created in the likeness of God with rulership over the earth given to them. This view would give non-Adamics a higher place in God's order that is not scriptural. This view is ridiculous as we read on to the so-called second account we can see that the above verse is in reference to the Adamic or White race. **And God formed man, dust from the earth, and breathed into his face a breath of life, and the man became a living being. And the Lord God planted an orchard in**

Edem toward the east, and there he put the man whom he had formed. (Genesis 2.7,8)

This account is about the Adamic race, which can readily be seen by the ancient Hebrew word Adam or its Greek equivalent anthropos (άνθρωπου). The Anthropos is the Adamic race created by God. As a proper name, Adam is Ἀδάμ in Greek. Now we look at the way an Adamic was defined from ancient times. Adam was not just a name but the racial description of the Adamic race and Adam's "ruddy" descendants. Strong's Hebrew 119 has: "to show blood (in the face), i.e. flush or turn rosy; be (dyed, made) red (ruddy)." The form translated "man" or "men" is H 120: "from 119; ruddy, i.e. a human being (an individual or the species, mankind, etc.)."

In Scripture, we have an example of Adamic ruddiness in David. **And he sent and brought him in. And this one was ruddy with beauty of eyes and was good in appearance to the Lord. And the Lord said to Samouel, "Rise and anoint David; for this one is good." (1 Reigns 16.12 LXX) (1 Samuel 16.12)** The Greek word translated as ruddy is πυρράκης (pyrrakis). It is defined as a red or ruddy person. Jesus describes Himself as of the race of David and the beginning of that race, the Adamic race He chose out of the earth. **I Jesus, sent My messenger to testify these things to you over the Body Politics. I am the Root and Race of David, the bright and morning Star. (Revelations 22.16)**

When the ancient Hebrew scriptures were translated into the Greek Septuagint, in most cases the translators rendered the Hebrew Adam with the Greek άνθρωπος (Anthropos) meaning, man, human; the men, people (of Judah); man. Anthropos is believed to be a combination of the Greek words aner άνήρ (aner) meaning man emphatically as opposed to woman, and the word ὤψ (ops) the face or countenance, in other words "man faced." This has racial and biblical significance. Ruddiness is a specific Adamic characteristic.

The Greeks viewed the true man to be "White" like the images we know from the classical fair-haired, fair-skinned, Greek artworks. This view is implied in the Bible as the Adamic race. It is the characteristic of Adamics to be ruddy, to show blood beneath the skin. This is indicative of showing the life within the vessel. The metaphor of Adamic man being a vessel filled with the Mentality of God is found often in the Scriptures. This is the true man, the Adamic filled with Mentality. This is the spiritually significant characteristic of Adamics...**and breathed into his face a breath of life, and**

the man became a living being. (Genesis 2.7) Adam man became a living being because God bestows upon him the “Breath of Life”.

The “Breath of Life” makes Adam a “Living Life”. This is the spiritual life that God gave to the Adamic race, which separates it from the rest of God’s creation. The word “Life” used in “living Life” is the Greek word ψυχή (psuche) has the meaning of life; soul; id. (as center of the inner life of pers.); id. (as center of life that transcends earthly life); conscious self, personality; person, individual; soul, self. This word is often translated as “soul”. It is much more than the life found in all living beings. This word is about the spiritual life God bestowed on Adam. This biblical concept is reinforced throughout the Scriptures. The New Testament in particular makes it a central point of the persuasion. The man who does not have “Life” or the Separated Mentality of Christ is spiritually dead. The man who has “Life” or the Separated Mentality is spiritually alive. **So also it has been written that the first man, Adam, “became a living life,” the last Adam a life-giving Mentality. (1 Corinthians 15.45)**

In **Genesis 1.1-25** is an overview of creation. The universe, the earth, and all its plant and animal life were made and God called it good. In verse, **26** God creates Adam man and gives him dominion over all other creation on earth. In verse **27** it is stated that God made Anthropos-Adamic kind in the divine image. In the following verses, God finishes His work and blesses the seventh day. Now in **Genesis 2.4**, we come to the thesis of the book. **This is the origin of heaven and earth, when it originated, on the day that God made the heaven and the earth.** This verse restates the events of creation leading to the focal point of God’s work which is Adamic man. Continuing in verses **2.5-6** it goes on to state yet again that God had created the herbs of the field and caused the earth to be watered. Looking back to the first chapter we can read that this has already happened by the fourth day. If there are two creation accounts then there would have to be two accounts of the creation of herbs and water. We understand that this is simply not so. If we follow the logic of the two-accountist, then we would also have to throw in a third account of creation. At the beginning of Genesis chapter five, there is an account of the creation of the Adamic kind. **This is the book of the origin of human beings. On the day that God made Adam, he made him according to divine image; male and female he made them, and he blessed them. And he named their name “Adam” on the day he made them. (Genesis 5.1,2 LXX)** Read in its whole context, we can now see that there are not two or three different accounts of creation but one. The beginning of Adamic creation is stated three different times. The story of creation in Genesis

begins as an overview that narrows down to the focal point of Adamic man, God's vessel.

The first account gives the creation of both the man and woman in verse 27... **male and female He made them.** Now the second account gives the creation of the Adamic race in greater detail. Allegory is used in Genesis to explain the creation and fall of man. This story represents the entire Adamic race and is better understood when the silly notion that God only created one man and one woman is thrown away. Adam and Eve are representative of all the first Adamics created by God. Look again at the first account of creation and see that the Adamic race was created. **Then God said, "Let us make humankind according to our image and according to likeness, and let them** (this is plural, as in the race) **rule... And God made humankind; according to divine image He made it; male and female He made them. (Genesis 1.26,27 LXX)** Remember this account is again reiterated in **Genesis 5.2...And he named their name "Adam" on the day he made them.** God makes the Adamic race and He calls them "Adam". As was just explained Adam is the living vessel of God meaning they had spiritual life.

It gets interesting here now that we know that the first account was speaking pluralistically of the Adamic race. In the second account of creation, the story is simplified to the singular sense. Man, the anthropos/Adam was created in the first account and it was in reference to both male and female Adamics. We know that it switches to the singular here in verse 2.7 because in Greek it says τον άνθρωπου which is 'the man'. The τον (ton) is a singular particle and it signifies that the account is singular now, telling of Adam and Eve who we know to be a representation of all Adamics.

The Fall of Adamic Man

Adam was once a perfect creation. We know he was perfect because he once walked and talked with God. Adam was pure or godly in both body and mind. So, now we come to the meat of the story. What was it that corrupted Adam? Why was he (remember, the Adamic race) expelled from Eden and why was his spiritual communication with the Almighty ended? This question will be answered as this study on the origin of sin and death opens up the racial and spiritual truth of God's Word.

At this point, we must address an issue before proceeding. There have been some unscrupulous individuals who, despite a thorough explanation, persisted in their willful ignorance. They made the ridiculous claim that this article supports mongrelization. They claimed the authors hold Jesus Anointed to be a mongrelized man from non-Adamic stock. We want to assure the reader that nothing could be further from the truth. There is no such evidence, claim, or suggestion by the authors of this work that Jesus Anointed was anything other than the pure Adamic Son of God. There is no evidence for their heretical claims in the Bible or any other literature associated with this work or its Body Politic.

Eve did something so horrible that it got everyone kicked out of the Garden. She had children. One was born bad, one was born good. The bad one killed the good Abel and was exiled from Adamic society. Seth was raised up in the place of Abel. **Now Adam lived two hundred thirty years and became a father, according to his form and according to his image and named his name Seth. (Genesis 5.3 LXX)** We see that Seth was raised up according to the form and image of Adam. This is both racial and spiritual. Cain was born bad; he was not in the form and image of Adam. What follows is an explanation of how mongrelization, both physical and spiritual came into the world.

Now we will look at the fall of man and ask an important question: Who was Cain's father? Most anyone will tell you that Cain was the son of Adam. However, Cain was the son of the "evil one" as we read in John: **not as Cain, who was of the evil one, killed his brother, and for what did he kill him? Because his works were evil but those of his brother were just. (1 John 3.12)** The evil one in this verse is about the Diabolical One or devil who is spoken of in the preceding verse **10: By this are the children of God and the children of the Diabolical One revealed: Everyone not doing justice is not of God; also, he not loving his brother.** John is telling us here that Cain was a son of Satan, the Diabolical One. Jesus also condemns the Pharisees, calling them the children of Satan. **You are of your father the Diabolical One, and the lusts**

of your father you wish to do. That one was a murderer from the beginning, and he has not stood in the truth because there is no truth in him. When he speaks a lie, he speaks from his own, because he is a liar, and the father of it. (John 8.44) We can see here that both Cain and the Pharisees of **John 8** were all children of Satan. The racial statement of brotherly love is attached to godly justice here. Both the Pharisees and Cain hated their brethren. So, who exactly was Cain's father?

When **Genesis 4.1,2** is read carefully we see that Cain and Abel were twins. **Now Adam knew his wife Eve, and after she had conceived she bore Cain and said, "I have acquired a man through God." And proceeded to bear his brother Abel. And Abel became a herder of sheep, but Cain was tilling the earth.** Now, while Eve said she had a man from God, she was deceived or continued to lie to herself and her husband. Most people have a problem with this verse and will dismiss you out of hand when you point out that Cain and Abel were twins with separate fathers. Yes, separate fathers. Heteropaternal superfecundation is the medical term for when a second ova is released during the same menstrual cycle and is fertilized from the sperm cells of a completely different man in separate sexual intercourse.

If we look back to **Genesis 3.15** we can see where God says that He will put enmity between the woman's children and between Satan's children. **And I will put enmity between you and between the woman and between your offspring and between her offspring;...** God is telling us what is happening here with the two different children of Adam and Satan. In **Genesis 3.16** God tells the woman that she will bear children (plural). God says that He will increase her pains and she will bear children. God is telling us about the twins Cain and Abel. **And to the woman he said, "I will increasingly increase your pains and your groaning; with pains you will bring forth children. ..."**

It is the offspring of Satan, from his communion with Eve, that will forever have enmity with the offspring of the woman. The offspring of Satan was Cain, the offspring of the woman was Abel, and the enmity was there from conception. One can seek to make this transgression of Eve's something less, but why challenge the Word of God? Why strain the interpretation of what Jesus told the Pharisees when He told them they were Satan's children and they were not able to hear His words? **He who is of God hears the words of God; for this reason you do not hear, because you are not of God. (John 8.47)**

Let's look at the testimony that Eve gave to God as to why she had disobeyed. **And God said to the woman, "What is this you have done?" And the woman said, "The**

snake tricked me, and I ate.” (Genesis 3.13 LXX) Now, as we will see, this verse should rightly be translated: **And God said to the woman, “What is this you have done?” And the woman said, “The snake sexually seduced me and I ate”**. The words “sexually seduced” are translated from the Greek word ηπάτησέ (hepatese) which is one of the many forms of ἀπατάω (apataó). It is defined as: to divert, to cheat, to deceive; to distract; to seduce. Bauer defines it as “deceive, cheat, mislead. Seduce sexually. Enjoy oneself, live pleurably”. Eve has confessed here to being sexually deceived by Satan. However, this does not mean she had sex with a snake, though she did have sex with somebody.

We must take notice here that Eve did not say that the snake gave her “fruit”. No, Eve says that she was seduced, and tricked by the snake. To live pleurably is also implied here. Pleasure, the lusts of the world, has a deceiving snake-like allure. Living for worldly pleasure is living under a deception because pleasure takes that which has no real profit for the spiritual and replaces it with physical satisfaction. **But the one living in self-pleasure has died while living. (1 Timothy 5.6)**

Back in the third chapter of Genesis, we can read about Eve’s talk with the snake. In **Genesis 3.3** Eve says, **but of the fruit of the tree that is in the middle of the orchard, God said, ‘You shall not eat of it nor shall you even touch it, lest you die’**. Now a more Christian translation of this verse would be: **but of the fruit of the tree that is in the middle of the orchard, God said, ‘You shall not eat of it nor shall you have sex with it, lest you die’**. Most modern translations of the Scriptures purposely take out or change certain words, which in turn gives a different reading. This fact is beyond the scope of this work. However, we will now look at the very different translations we have given here.

The phrase translated as “have sex with” is from the Greek ἀψησθε. This word is the 2nd person plural form of the word ἅπτομαι (haptomai). It is defined in Liddell & Scott as: fasten oneself to, grasp, take hold of, cleave, touch, effect, have intercourse with a woman. Thayer’s says: To fasten oneself to, adhere, cling to. a. to touch b. of carnal intercourse with a woman or cohabitation. c. of levitical practice of having no fellowship with heathen practices. Things not to be touched appear to be both women and certain kinds of food, so celibacy and abstinence of certain kinds of food and drink are recommended.

Another example is in **Genesis 20.4 Now Ambimelech had not touched her and he said, “ Lord, will you destroy an unwitting and righteous nation?”** That is he had not been with her sexually. The word used here is ἥψατο (hepsato) again it is a form of haptomai (ἅπτομαι) it does mean to touch, though it is linked with haptomai and its sexual connotation to know carnally, and the word itself implies something going out from the touch. **Then God said to him during his sleep, “I too knew that you did this with a pure heart, and I was the one who spared you so that you did not sin in regard to me. Therefore I did not allow you to touch her”.** (Genesis 20.6 LXX) Again the word touch used here is a form of haptomai. It is obvious from the text here that the word touch is being used instead of sexual intercourse. The Christian needs to understand what Ambimelech was going to do with Sarah. Was he poking her with his finger or is the verse talking about sex?

Next, we look at the issue of “Trees” used in the Bible, specifically in Genesis. The woman said **but of the fruit of the tree that is in the middle of the orchard, God said, ‘You shall not eat of it nor shall you even touch it, lest you die’** (Genesis 3.3 LXX). We call attention to the word tree here. ξύλον (xulon) is the Greek word translated as tree in this passage in most Bibles. ξύλον is defined as: wood, firewood; timber; wooden image, idol; handle; shaft (of a spear); wooden collar, yoke; stocks (as instrument of punishment); tree;. Basically, this word meant anything made of wood. The allegory of the Genesis creation and fall of man story unfolds as we understand how these words were used. A note to the reader: the word ξύλα is used in many of the verses that speak of trees. This word is merely a plural form of ξύλον.

Tree is used metaphorically throughout the Bible for certain people and various nations. Of course, Jesus is the tree that we are grafted onto so that we might bear spiritual fruit. **I am the True Vine, and My Father is the Vine dresser. Every branch in Me not bearing fruit, He takes it away; and each one bearing fruit, He prunes so that it may bear more fruit.** (John 15.1,2) In Ezekiel chapter thirty-one, there is a beautiful metaphor using trees concerning the fall of Assyria. This was given as a warning to Pharo by the prophet. **Behold, Assyria is a cypress in Lebanon; beautiful in limbs he is and high in size; his top came to be into the midst of clouds.** (Ezekiel 31.3 LXX) Here in verse nine, we can see that the trees (God’s people) in the orchard of delight (Eden) were jealous. Now how can a tree be jealous of another tree? The answer is that this is a metaphor for men. **On account of the abundance of his branches. The trees in the orchard of God’s delight were jealous of him.** (Ezekiel 31.9 LXX) ...

And all the trees of delight even the choice ones of Lebanon, all that drink water, were consoling him on earth. (Ezekiel 31.16 LXX) So now we can see that the use of ξύλον for people is used in the Bible and also for peoples in Eden. Here are a couple more examples out of the many used in Scripture. **But I removed the Amorrite from before them, whose height was as the height of a cedar, and who was as strong as an oak, and I removed his fruit above and his roots beneath. (Amos 2.9) For if you were cut out of the natural, wild olive, and were grafted against nature into a good olive, how much more these being according to nature will be grafted in their own olive tree? (Romans 11.24)**

Tree is used in a racial sense in the story of Adam and throughout the Scriptures. The Adamic race, God's portion was forbidden to racially mix with a certain racial tree that God had pointed out. This is a very important point when understanding who it was that Eve had sex with that caused the fall of Adam. God says that He will put enmity between the offspring. **And I will put enmity between you and between the woman and between your offspring and between her offspring; he will watch your head, and you will watch his heel. (Genesis 3.15 LXX)**

There was an enmity between Cain and Abel from the beginning. Also is the fact that the snake is said to have offspring or descendants. The offspring of the snake are forever opposed to the offspring of the woman. It can also be noted here that the enmity between offspring verse comes before Eve is said to have had Cain and Abel. The snake represents Satan and the offspring of the snake is the mongrel offspring that was created by the forbidden act of sex that Eve and then Adam engaged in. With this understanding let us look at a Christian breakdown of **Genesis 3.3** that might be made without a satanic influence misrepresenting God's Word. **but of the fruit [offspring, a racial family] of the tree [race] that is in the middle of the orchard, God said, 'You shall not eat [cohabit with non-Adamics] of it nor shall you even touch [have sexual intercourse] it, lest you die [die by the death, that is die spiritually which leads to mongrelization in all forms including racial death].**

Adam and Eve are an illustrative example of the Adamic racial nation who were forbidden to procreate with a particular race of people or non-Adamics. This non-Adamic race was some form of hominoid, possibly the original negro race. They were categorized as animals, beasts of the field. The snake, who represented Satan presented himself as an authority. He claims authority over God's Word in **Genesis 3.4** where he tells Eve that she will not die by death for taking the "forbidden fruit". Satan implanted

the idea in Eve's mind that to racemix with animals against God's command was a good idea. This satanic idea led to the impregnation of the snake's offspring, that is a mongrel offspring. Eve, or some Adamic women had sexual intercourse with a non-Adamic hominoid.

Now the snake was the most sagacious of all the wild animals that were upon the earth...(Genesis 3.1 LXX) For clarification, the word sagacious is from the Greek φρονιμώτατος a superlative form of φρόνιμος (phronimos). It is defined as: wise, prudent; clever; understanding; wise, enlightened. The words "wild animals" are translated from the Greek θηρίων, the neuter form of θηρίον (thērion) it is defined as: wild animal, beast; monster.

Now Eve, who represents a portion of Adamic women, did not have sex with a snake. An Adamic woman can't have offspring fathered by a snake. Any sane person knows this. Unfortunately, many insane people want to make science fiction out of the Biblical allegory. What is even worse is the sad fact that several good folks are led astray by idiotic stories of snake people. Again Eve did not have intercourse with a snake and have a snake baby, thus creating a physical serpent race, etc.

The word snake is translated φοῖς (ophis) meaning: snake, serpent. The snake or Satan talked Eve into having sex with a wild animal, a beast of the field. This beast had to be able to procreate with an Adamic woman, creating a mongrel offspring. Not just any animal is capable of impregnating a woman. Only the highest order of hominoids is capable of that act. This Satan snake tricked Eve into disobedience. He seduced her and caused her to have intercourse with a beast, a non-Adamic hominoid. Their offspring was an uncreated being. It is not the work of God, but the work of lawlessness. This mongrel non-creation is opposed to God's natural order. Now we can see how Satan is the father of mongrels. Satan is the father of lies, and the mongrel is a physical lie because it is a mockery of God's purity. All mongrels are the seed of Satan. The satanic mentality cannot create, it can only corrupt. In the New Testament, this principle is expanded to anyone who opposes God, whether they are Adamic or not. Whether Physical mongrels or spiritual mongrels, these "people" are the "viper race", the satanic seedline so to speak because they follow their father Satan to help make a lie.

An earnest Christian may want to study this command which was given after prohibitions on various other sexual crimes regarding incest, bestiality with a quadruped, and homosexuality. A clause is added here that both the animal and the woman shall be

put to death because both are liable. Now we ask a question, how else can an animal be liable except that it has the presence of mind to know right and wrong? **And a woman who shall approach any animal for her to be mounted by it- you shall kill the woman and the animal; by death they shall be put to death; they are liable. (Leviticus 20.16 LXX)** Definitions of three keywords are given here. ‘‘Animal’’ is from κτῆνος (*ktēnos*) animal (domestic). ‘‘to be mounted by it’’ is the word βίβασθηναί which is the infinitive verb form of βίβαζω (*bibázō*) defined as: to be mounted, to have connection with (an animal) (of a woman). The word liable is from ἔνοχοι an adjective form of ἔνοχος (*enochos*) meaning: liable to, subject to; liable to action for; guilty; guilty of; acquainted with.

Notice it says at the end of the verse that both the woman and the animal shall be put to death. The reason for the sentence of death upon the lawless Adamics, the animals, and quadrupeds is not only to eradicate the degeneracy from among the population but to stop mongrel offspring from being born. To make this point we look at one of the many verses that explains mongrel children are proof that their parents had racemixed. We know for a fact that the subject is mongrelization here because an examination is made of the children to determine guilt. **For children born of unlawful intercourse are witness of evil against their parents when they are examined. (Wisdom of Solomon 4.6 LXX)**

We can see that Eve’s crime against God was race-mixing and her mongrel child was Cain. Satan came to the woman with a lie and Satan mongrelized the Word of God. Satan tells Eve ‘‘you will not die by death’’. All focus is put on the physical here at the cost of the spiritual. God had forbidden the racial mixing of Adamics with another race of hominoids. The tree for knowing good and evil is a metaphor for race mixing, the mixing of the good Adamic race with that of the animal, which is evil according to the law of God. Now Satan has put an idea into the woman’s mind that she would be a god if she disobeyed the commandment that was given to her.

Now while the woman was talking with Satan, Adam failed to act. Adam stood by while the Law of God was broken. Adam walked and talked with God. He communicated with God daily, and Adam knew what God meant when the Law was laid down. Adam was disloyal to the Almighty God at this point. The snake says **for God knew that on the day you eat of it, your eyes would be opened, and you be like gods knowing good and evil. (Genesis 3.5 LXX)** As we have already pointed out Satan was lying about the spiritual part here. The moment that Adamics disobeyed God, they died spiritually. The

physical death comes in the sense of murdering their race. Satan believes that if he can kill God's vessel on earth, then he will have beaten God.

Satan holds himself up as an authority to Adam and Eve. He convinces them that there is something they need and the only way to get it is to disobey God, who he said lied to them. Satan tells them "You will not die by death". God lied, Satan is the authority. This is the deceit that Satan and his children always use. They are always set up as authority figures, they always mix lies with the truth. **For such are false-ambassadors, deceitful workers, transforming themselves into ambassadors of the Anointed. Did not Satan marvelously transform himself into a messenger of light? It is not a great thing, then, if also his ministers transform themselves as ministers of justice, whose end will be according to their works. (2 Corinthians 11.13-15)**

Satan has given to the man and woman a wonderful narrative about how they will be like gods. How their eyes will be opened to some wonderful mystery. Satan tells them that they will not die. This is the blackest lie in history. Adam and Eve exalt the creature over the Creator when they gave heed to this lie. We now read of the disobedient action in **Genesis 3.6: And the woman saw that the tree was good for food [that the woman was capable of sexual intercourse with non-Adamics] and that it was pleasing for the eyes to look at [the deceived woman lusted after the animal] and it was beautiful to contemplate, and when she had taken of its fruit she ate, and she also gave some to her husband with her, and they ate.** [Eve had sinned and then she enticed her husband to join her].

Eve and Adam had now sinned against God. Adam participated with the woman in sexual degeneracy. Adam had a choice to condemn Eve and keep his honor before God but he chose to disobey. This was a cowardly act and there is no virtue in it. Adam's purpose was to be a servant of God. Adam was separated unto God from all other creation so that he might fulfill this purpose. Adam had been created to house the Mentality of the Living God. The greatest aspiration of Adamic man is to love God. Adam knew that Eve's sin was punishable by death because God had said so. However, Adam refused to enforce God's Law. The only way to keep God's Law is to enforce it. **For not the hearers of the law are just with God, but the doers of the law will be justified. (Romans 2.13)**

The woman did not have the authority here. It was Adam who had the authority and duty to have dominion over the earth. The woman was created as a helpmate for the

man. **Then the Lord God said, “It is not good that the man is alone; let us make him a helper corresponding to him.” (Genesis 2.18)** God curses Adam to labor for the rest of his life because he listened to the woman instead of his Creator. The woman is punished according to her function and the man is sentenced to labor because he failed to do the job given to him. **And Adam was not deceived, but the woman being deceived has become in transgression; (1 Timothy 2.14)**

Because the Mentality or Spirit of God is so Holy or separated from that which is evil, it cannot be in any contact with evil. In the very moment that Adam disobeyed God, the spiritual Life that God had bestowed on him departed. Adam no longer had the Mind of God abiding in him. He ceased to be a worthy vessel. This is the fall of the Adamic man, his loss of spiritual Life. Because Adamic men are now without spiritual Life is the reason for Christ, Who paid the blood debt owed by Adamics and bestows Life to those who submit to Him. This is the true message of God’s Word. Adamics who are without Christ are dead. Adam died spiritually when he disobeyed as God had decreed. **but of the tree for knowing good and evil, of it you shall not eat; on the day that you eat of it, you shall die by death. (Genesis 2.17).**

Here we should point out that the very first thing the Adamics did after “eating the fruit” is to sew fig leaves together and make loincloths to cover their reproductive parts. They did this in a pathetic attempt to hide their sexual sin from God. Their eyes were opened in that instant to the fact that they had sinned and their innocence had been lost. They were naked, and all of a sudden they realized that they were no longer under God’s protection. This is a further illustration that when they died spiritually, they exchanged God’s protection for that made of man and in its nature corruptible. **And the eyes of the two were opened, and they knew that they were naked, and they sewed fig leaves together and made loincloths for themselves. (Genesis 3.7)**

And the Lord God said to the snake, Because you have done this, cursed are you from all the domestic animals and from all the wild animals of the earth; upon your chest and belly you shall go, and earth you shall eat all the days of your life.

(Genesis 3.14 LXX) God pronounces judgment on Satan. The devil is cursed above all creation because of his mongrelization of God’s race. The devil is cursed to crawl on his belly and eat dust. This is understood by the thinking Christian as a condemnation of the devil and not just snakes themselves. We give no credence to the poor misguided fools who believe that all snakes were once “beautiful” and “had legs”! No, this condemnation proves that God is condemning Satan and not all snakes. The upright man

walks in the light of God, while the cursed man is rejected and vile and desires to hurt the man of God. Satan is the representation of all worldly lust. Lust is anti-Christ and God curses all who give themselves to it. The earth that Satan is to eat are those who are rejected by God. **Be not led astray, God is not mocked. For whatever a man may sow, this also will he reap: because he sowing to his flesh will reap mongrelization; but he sowing to the Mentality will reap everlasting life. (Galatians 6.7,8)**

The spiritually dead are like dirt -earth and return to the earth when their bodies die. This is because they are like empty clay vessels without the water of the Mentality filling them. **By the sweat of your face you will eat your bread until you return to the earth from which you were taken, for you are earth and to earth you will depart. (Genesis 3.19 LXX)** No snake or diabolical one can touch the children of God with spiritual death. They are vessels filled with the living Mentality. These are the separated ones who reside with God eternally after their physical death. **Do you not know that you are a house of God? If anyone mongrelizes the house of God, God will mongrelize that one. For the house of God is separate, which you are. (1 Corinthians 3.16,17)**

And I will put enmity between you and between the woman and between your offspring and between her offspring; he will watch your head, and you will watch his heel. (Genesis 3.15 LXX) Now we see from this verse that God puts enmity between the offspring of the woman and that of Satan. Starting in verse **14** God tells this to Satan. Enmity between the serpent's offspring, that is mongrels, non-created beings who came about through sin outside of God's order. This verse alone establishes that fact. But there is more, this enmity that God put between the offspring is part of Adamic man's punishment for disobeying God. Racial strife throughout the ages is a direct result of disobedience to the racial laws of God.

Some misguided folks try to nullify this Scripture by saying that the seed of the woman was Jesus. They are right in part because Jesus is the Seed. However, Jesus is the culmination of this story. The other offspring of the Adamic people who came before Christ came in the flesh cannot be forgotten or half the Bible would have to be thrown away. The story of Cain and Abel has a purpose. The story of Esau and Jacob has a purpose. The story of Job has a purpose. This is the war of the ages, the children of God against the children of Satan. Jesus was the last Adam and He came to give His people spiritual life. **So also it has been written that the first man, Adam, "became a living life," the last Adam a life-giving Mentality. (1 Corinthians 15.45)**

Cain and Abel

Now after her pronouncement of punishment, Eve has Cain and Abel. Notice here that the Scripture says she conceived and had Cain and proceeded to bear Abel. This reinforces the point we have already made that Cain and Abel were twins. This concept is repeated in the Bible with the story of Esau and Jacob. They were also twins. Esau cared not for his birthright and threw it away. Jacob was a man of God, and after many trials became the father of the Israelites. **Now Adam knew his wife Eve, and after she had conceived she bore Cain and said, "I have acquired a man through God." And she proceeded to bear his brother Abel... (Genesis 4.1,2 LXX)**

Eve seems to be referencing what God had told her, that she would bring forth children. It was not Cain who was from God but Abel. Remember earlier when we discussed how two children could be born from two different fathers? The brothers Cain and Abel here are a representation of a generation or generations of Adamic and mongrelized children. The Adamic children had the capacity to love their Creator and a yearning for God. The mongrel children, even those who rejected their birthright, hated the Creator because they were not from Him. They also hated God's Adamic creation. This is brother – murder and no brother murderer can enter the Government of God. Eve, a representation of the traitorous Adamic women falsely believed she had acquired a child through God. However, her union with non-Adamics was not God's will. Remember God had told her that there would be enmity between her offspring.

Some well meaning people give ill judged weight to Eve's words here. If we continue to read the story, the next part is where Cain kills Abel. It continues to tell of how Cain was cursed and gives an account of his offspring with the last being a murder. Compare this with her words about Seth where Eve says God has raised up another son in place of Abel. ...**"For God has raised up for me another offspring instead of Habel, whom Kain killed."** (Genesis 4.25 LXX) Cain is mentioned as the murderer here. It is Seth who takes the place of Abel to carry on the godly line of Adam. If weight is given to Eve's words on Cain's birth then the same if not more weight should be given to what she has to say about Seth.

And it came about after some days that Kain brought to the Lord an offering of the fruits of the earth, and Habel, he also brought of the firstlings of his sheep and of their fat portions. And God looked upon Habel and upon his gifts, but on Kain and on his offerings he was not intent. And it distressed Kain exceedingly, and he

collapsed in countenance. (Genesis 4.3-5 LXX) Continuing with the allegorical style of Genesis, we see that God has looked with favor on Abel, but He cared not for Cain. Now we can see the questions coming up about why God did not accept Cain's offering.

Remember that God had already declared that there would be enmity between the offspring of the woman and that of Satan. What offspring do you think God was talking about? Why was Cain filled with jealousy and hatred of his brother Abel from the beginning? Why was Cain unable to divide his offering correctly?

God has regard to the one making the offering and not to the offering itself as the uneducated would think. Abel was a child of God. He acted with purity and sincerity and God saw this in his nature. Abel had this attribute because he was able to have it, whereas Cain was not. Cain hated his brother. Cain was not of God and he could not understand what the symbolic offering to God meant. He could go through the motions but he was not regarded by God. Cain's offering was a physical "copy" of what his brother was doing, it was not sincere. It had no spiritual part. **If anyone says, "I love God," and hates his brother whom he has seen, he is not able to love God Whom he has not seen. And we have this commandment from Him, that the one loving God also loves his brother. (1 John 4.20,21)** Cain had no love for his brother because the mongrel hates purity, just as race traitors today have no love for their racial brothers and betray them to death.

If you offer correctly but do not divide correctly, have you not sinned? Be still; his recourse is to you, and you will rule over him. (Genesis 4.7 LXX) The recourse of Cain is to sin. The recourse of Cain is to sin, and sin will rule over him. This is the pronouncement of God. This comes right before Cain kills Abel. Abel represents a whole generation or generations of righteous Adamics who fell victim to a whole generation or generations of lawless Cains. The representation of classes of people through Cain and Abel is an archetype used to weave these stories together for our education. This story is still relevant today. The fall of Adamic man continues through the same story in the houses of the Joneses and Smiths even now. This changed the nature of God's relationship with Adam man, and it brought into the physical world a litany of other evils, such as hate, and jealousy, murder, and strife. The devil is the father of these conditions, not God. To assuage Cain of his culpability is to forgive the devil himself for his culpability in the Genesis account. Cain was a brother murderer. He was an uncreated being who hated God and His chosen race. This is the lust of Satan. The "Cains" whether mongrels or traitors cannot be regarded by God because they are His

enemies and not His sons. **Because this is the message which you heard from the beginning, that we should love one another, not as Cain, who was of the evil one, killed his brother, and for what did he kill him? Because his works were evil but those of his brother were just. (1 John 3.11,12)**

God tells Cain that he has sinned. God is speaking to His enemy here. God did not accept Cain's sacrifice and He did not tell Cain everything was OK. God had just rejected Cain's offering. Cain hated God and he killed Abel because Abel was accepted. ...**his recourse is to you, and you will rule over him....** Cain's recourse was to sin and his act of wickedness was to rule over him. God cursed Cain and therefore all mongrels both spiritual and physical. God knows what Cain's impiety will lead to. This lesson shows us that one wicked act is followed by a worse one. **And now you are cursed from the earth, which has opened wide its mouth to receive your brother's blood from your hand. (Genesis 4.11 LXX)** In the narrative right after Cain is rejected he kills Abel. This is a parallel with Jesus. The world hates Christ and all who are of their father the devil hate Him and all who are His. **If the world hates you, you know that it has hated Me before you. If you were of the world, the world would love its own. But because you are not of this world, but I chose you out of the world, for this reason the world hates you. (John 15. 18,19)**

It is important to look at how the New Testament authors and Jesus Christ himself viewed Cain's origins. In the book of **John** Jesus says "**Why do you not understand My speech? Because you are not able to hear My Word. You are of your father the Diabolical One, and the lusts of your father you wish to do. That one was a murderer from the beginning, and when he speaks a lie, he speaks from his own, because he is a liar, and the father of it.**" (John 8.43.-44) Jesus was speaking to a group of people that included people who were both mental mongrels, and physical mongrels, but when He says they are "of their father the devil", He means that literally. Many standing in that crowd when He spoke those words were Edomite Judeans who were genetically non-Adamic. Notice here that Jesus did not tell these people to repent. He said they were not able to hear Him.

Certain people are incapable of good works. **He who is of God hears the Words of God; for this reason you do not hear, because you are not of God. (John 8.47)** The offspring of Satan are unable to hear the Word of God. The mongrel person is unable to indwell the Mentality of Christ. We learn of Cain's true origin in this next verse: "**Because this is the message which you heard from the beginning, that we should**

love one another, not as Cain, who was of the evil one, killed his brother, and for what did he kill him? Because his works were evil but those of his brother were just. (1 John 3.11,12) Notice that it says "**Cain, who was of the evil one.**" This is a corollary to Jesus' words in **John 8** , the one who was a murderer from the beginning, the one who was "**of his father the Diabolical One.**" The one who physically represented the first transgression of Adamic man into the sin of race-mixing was Cain. Some will argue that Cain went and mongrelized after he was expelled from the garden and took up with a non-Adamic wife and it started there, but that is not what the passages say. It says that Cain was of the evil one, of his father the devil, a murderer from the beginning- not after he was born and fell from perfection through some sin he committed. He was not the first to transgress -no, it was his mother Eve. "**From a woman is the beginning of sin, and because of her we all die.**" (**Sirach 25.24 LXX**).

It was the offspring of Satan (from his mongrelizing of Eve) that would forever have enmity with the offspring of the woman. The offspring of Satan was Cain, the offspring of the woman was Abel, and the enmity was from conception. One can seek to make this transgression of Eve's something less, but why challenge the words of Christ? He had no problem telling a group of Edomite Pharisees that Cain was the offspring of Satan. Jesus calls the Pharisees mongrels and says their father is Satan. This includes both physical mongrels and mental mongrels, those Adamics who reject Christ. Christianity brings both the body and the mind into account. Under the Law of Christ, it is not enough to hear the Word. The Christian must do the Word. Jesus tells the Pharisees whose children they are. **You do the works of your father. (John 8.41)** The Pharisees answer that they were not born mongrels from whoredom. **Then they answered to Him, "We were not born of whoredom; we have one father, God."** (**John 8.41**) The word whoredom here is from the Greek πορνεία (porneia), defined as whoredom, fornication; sexual urges; unfaithfulness and apostasy (in relation to God). This verse is an allusion to Deuteronomy: **One from a prostitute shall not enter the assembly of the Lord. (Deuteronomy 23.2 LXX)**

Jesus was calling these Pharisees mongrels and they knew it. Jesus continues to explain that they are not of God, they are outside of God's creation and they are not able to understand the words or knowledge of God. Just as God says to Cain that his recourse is to sin, Jesus tells the Pharisees that they will do the evil works of their father the devil. **Then Jesus said to them, "If God were your Father, you would love Me, for I went forth and have come from God. For I have not come from Myself, but that One sent**

Me. Why do you not understand My speech? Because you are not able to hear My Word. You are of your father the Diabolical One, and the lusts of your father you wish to do. That one was a murderer from the beginning, and he has not stood in the truth because there is no truth in him. When he speaks a lie, he speaks from his own, because he is a liar, and the father of it". (John 8. 42-44)

Now we return to the Genesis account where Cain killed his brother Abel. After Cain had done his wicked deed, God cursed him and drove him out of Eden. **And God said, "What have you done? The voice of your brother's blood is crying out to me from the earth! And now you are cursed from the earth, which has opened wide its mouth to receive your brother's blood from your hand."** (Genesis 4.10,11 LXX) The innocent blood of Abel cries out to God. We have proof of the spiritual truth here. God hears those who are His. When His children are hurt, God knows. In **Hebrews 9.22-26**, we read that the cancellation of the blood debt cannot come about without bloodshed. **...and without bloodshedding, there comes no remission.** This is why only Jesus in His innocence could pay for the sins of the Adamic world. The enemies of God are cursed because they are not part of the created order.

The sacrifice of the old Mosaic law was only held for a time until the coming of Christ. Jesus, however, was far superior to all earthly sacrifice. Earthly sacrifice was only for an earthly symbol and could not pay the debt owed to God Almighty. Jesus was the true sacrifice and He stands in the Government of Heaven as our Savior. **And almost all things are purified by blood according to the law, and without bloodshedding, there comes no remission. It was needful then for the figures of the things in the heavens to be purified with these, but the heavenly things themselves by better sacrifices than these. For the Anointed did not enter into the Separated Place made by hands, figures of the true things, but into Heaven itself, now to appear in the presence of God for us; not that He should often offer Himself, even as the high priest enters into the Separated Place every year with the blood of others, since He must often have suffered from the foundation of the world. But now once, at the completion of the ages, He has been revealed for the putting away of failure through His sacrifice. (Hebrews 9.22-26)**

So, Cain was driven out and he went to live in the land of Nod. Cain took a wife and had children. Who was Cain's wife? Where did she come from? Idiot Judeos will say it was his sister, which is absurd. Cain took a non-Adamic wife. The seeds of Cain were mongrels. In fact, mongrelizing is known as the "way of Cain" in the Bible. We go to

Jude here for an explanation of God's enemies throughout the ages. **And even as Sodom and Gomorrah, and the cities around them, in the same manner as they did give themselves over to whoredom in going after strange flesh, laid down an example in that they underwent the vengeance of everlasting fire, (Jude 7)** Now it says that the whoredom of Sodom and Gomorrah was going after strange flesh among its other sins which are discussed elsewhere in Scripture. The words strange flesh are translated for σαρκὸς (sarkos) defined as flesh. ἑτέρας (heteras) another; other; one or the other (of two). Mongrelization was the issue here both racial and gender as the Bible tells us. In the very next verse, it is made clear, saying that those who mongrelize have a perverted imagination. **Likewise also, these of perverted imagination mongrelize the flesh, hate mastership, and blaspheme the reputation. (Jude 8)** The word mongrelize here is μιάνουσιν (miainousin), a form of μιάνω (miainó) which means to taint, to defile, to pollute (of sacred things); to declare defiled, unclean; to defile (a woman) (in case of adultery); to be defiled; to be unclean.

But what things they do not know, they speak blasphemy of these, and what things they understand only instinctively, like animals without reasoning ability, they mongrelize by. (Jude 10) The "way of Cain" continues to be explained here with one of the best verses in the Bible. Mongrels and the enemies of God are animals because they have no spiritual Life. They cannot understand the Word of God. **Woe to them because they went the way of Cain, and have given themselves up to the error of Balaam for reward and destroyed themselves in the gainsaying of Core! (Jude 11)** We have two famous examples of the way of Cain here. Balaam the prophet thought he could still be God's prophet and endorse God's enemies at the same time. What did Balaam endorse with the king of Moab? Of course, it was race-mixing with the forbidden people of Moab and idol worship. **And Israel stayed in Sattim, and the people were profaned by whoring with the daughters of Moab. And they invited them to the sacrifices of their idols, and the people ate of their sacrifices and did obeisance to their idols. And Israel was initiated to Beel-Phegor, and the Lord was angry with wrath against Israel. (Numbers 25.1-3 LXX)**

Core was a rebel. He led a rebellion against Moses. He contradicted Moses who gave instructions from God. Core and all his fellow God traitors were swallowed up by the earth which opened up beneath them. They were taken straight to Hades, which is spiritual death besides physical death. **And the earth was opened and swallowed them down, and their households and all the men who were with Kore and their cattle.**

**And they went down, they and as much as was theirs, alive into Hades, and the earth covered them, and they perished from the midst of the congregation.
(Numbers 16.32-33 LXX)**

Now that the “way of Cain” has been explained we can continue with the story of Cain. Cain is cursed by God and he is given a sign by God so that no one would kill him. He took a wife from the non-Adamic people in Nod. He built a city with them and named it after his first son Enoch. It should also be pointed out here that Cain could not have built a city with only his sister. Cain was with the non-Adamics. A sign was given to him or rather to a whole generation of lawless Cains who were mongrels or Adamics who had betrayed their creator. The mongrel Cains are separate from creation, they are uncreated beings outside of God’s Order. They are unreasoning beasts incapable of spiritual life. Their existence is a consequence of the breaking of God’s racial law.

At this point, we must again address the issue of whether Cain was born a mongrel or not. Despite all the evidence that has been shown in the preceding paragraphs, some still deny this. If the argument is that Cain should not have been afforded a mark of protection if he were a non-Adamic, then the argument must also be that he should not have had a mark because he was a brother murderer. The law records that a murderer shall be put to death. So, making an issue out of the mark of Cain in this context does not solve anything but replaces one problem with another. The punishment of Cain was that he was exiled from the Adamic nation. His works will not have gain. Here is a question for the Christian. Was the product of sin started through a creation of God or an unnatural creation, that is the mongrel Cain?

Arguing about the mark neglects the discussion of the sexual overtones of the Genesis account. The analogy of the fruit and the snake and the tree has been understood for thousands of years to be symbolic of sexual transgression. There is no advantage in delaying by one generation the creation of a mongrel subspecies. Even if it could be proven that Cain was not a mongrel, he was certainly a God traitor. His actions still had the same outcome and the biblical narrative does not change. This transgression changed the vessel (God’s chosen race) to something that was unacceptable and could not indwell the Separated Mentality of God.

The mark of Cain or the banishment of the lawless from the Adamic nation is a punishment for the Adamics which had disobeyed God. God’s Word is for Adamic man only. Once God’s law is broken there are consequences. Eventually, God’s wrath is filled

up and divine vengeance is taken. This is built into the natural order of the world. Remember God's proclamation that the seed of the snake would have enmity with the seed of Adam. Adamics will watch against their head and the mongrels will watch against the crushing heel of the Adamic seed. Adamic man was given charge over the entire world, and he ruined it by disobeying God and not exacting the control he should have. Through his failure to be a steward of the planet, Satan found entry into the physical realm. The consequence of this is mongrelization in all its forms.

To make this event of mongrelization happen with anyone other than Eve and her mongrel son Cain is to contradict innumerable Scriptures throughout the Old and New Testaments. The record is clear and no gain is had in making Cain an Adamic man. He is the archetypal antithesis of the Adamic man, a liar, a God-traitor, and a murderer from the beginning. Cain was a mongrel son of Satan, the snake's offspring at enmity with the Adamic offspring forever. **Everyone hating his brother is a murderer, and you know that every murderer does not have everlasting life remaining in him. (1 John 3.15)**

The account of Cain and his descendants ends after the fifth generation with Lamech. He had done the lusts of his father just as God has said in the Old and New Testaments. We believe this to be the point of the few verses about Cain's offspring. Lamech was a murderer and he scoffs at God's mark on Cain, claiming it as a protection. This man is arrogant before God. He cannot understand the judgment of God because he is unable. He cannot understand that he is not recognized by God. It is fitting that right after the verses about Lamech, the birth of Seth is announced. Eve declared **"For God has raised up for me another offspring instead of Habel, whom Kain killed."** (Genesis 4.25 LXX) **Seth has a son he named Enos and he hoped to call on the Master God with this son of his. This was a symbol of the continued existence of those Adamics who still followed God. And to Seth, a son was born, and he named his name Enos. He hoped to invoke the name of the Lord God. (Genesis 4.26 LXX)**

Chapter five of Genesis begins with the origin of Adamics. It retells the story of the Adamic nation, of Adam and Eve. Who here represent the Adamics who were persuaded by God. This is the beginning for the Christian student. It is the beginning of the divine seedline, the spirit bearers of God who carried His message throughout the ages. This is the book of the origin of human beings. **On the day that God made Adam, he made him according to divine image; male and female he made them, and he blessed them. And he named their name "Adam" on the day that he made them. (Genesis 5.1,2 LXX)**

Seth is named as the son of Adam here, with no mention of Cain. Seth is the offspring that was born in the image and race of Adam. Notice here that Seth was created in the image of Adam as God had intended, unlike Cain. Recall the similar verse in **Genesis 1.26 Let us make humankind according to our image and according to likeness.. Now Adam lived two hundred thirty years and became a father, according to his form and according to his image, and named his name Seth. (Genesis 5.3 LXX)** Seth is born according to the form and image of his father. This is a racial description. Seth is the correct Adamic vessel capable of housing the Separated Mentality of God. The descendants of Seth go on throughout the ages. Noah was a descendant of Seth as was Abraham. Jesus Himself is traced to Seth, his father Adam, and to God. **...of Seth, of Adam, of God.(Luke 3.23-38) See also the lineage given in Matthew 1.1-16.** It is also interesting to note that the seventh generation from Adam through Seth was Enoch and he was a righteous man that God took up into Heaven. **And Enoch was well-pleasing to God, and he was not found, because God transferred him. (Genesis 5.24 LXX)** The seventh from Adam through Cain was Lamech the murderer.

The Genesis story of Adam truly starts in chapter five with the birth of Seth. What came before Seth was merely the prologue to set the stage for the saga of the fallen Adamic man and the struggles of Seth's descendants. Seth represented a whole generation of overcomers who held to God's Law and survived the degeneracy around them to preserve the genetic material of Adamic man. Seth's descendant Noah was recognized by God as being righteous and perfect in his Adamic family, his race. **Now these are the generations of Noe. Noe was a righteous man, being perfect in his era; Noe was well-pleasing to God. (Genesis 6.9 LXX)** Here era is poorly translated for the Greek γενεᾱ (genea). It is defined as generation; family; offspring; age. If we continue to read the story of Noah, we can see how Noah was indeed perfect in race and mentality in his era. **And the Lord God saw the earth, and it was ruined, for all flesh had ruined his way upon the earth. (Genesis 6.12 LXX)** All flesh was ruined. How else could this be interpreted but that the earth was ruined through race-mixing? The place God had made in the world for His chosen people had become corrupted. Noah was the Adamic man of God, who obeyed both physical and spiritual laws of God and would go on to restock the area that was flooded and cleansed for Adamic posterity. Noah gathered seven by seven of the clean animals and two by two of the unclean animals for repopulating the flooded area with cattle and other necessary animals to sustain life.

Disobedience

Why did God ask where Adam was? **And the Lord God called Adam and said to him, “Adam, where are you?” (Genesis 3.9)** Does anyone believe the omnipotent God did not know where Adam was? No, God asked where Adam was because Adam no longer had spiritual contact with God. God does not regard those who are in sin. Sin is traveling away from God, repentance is to turn around and go towards God. **Because you are not a god who wants lawlessness; one who does evil will not sojourn with you. Lawbreakers will not endure before your eyes; you hated all who practice lawlessness. You will destroy all those who speak the lie; a bloodthirsty and deceitful man the Lord abhors. (Psalms 5.5-7 LXX)**

Adam had disobeyed God and he died spiritually in that instant as God had said. Disobedience led to his spiritual death and it also had consequences in the physical world. The consequence in the physical world of disobedience leads to corrupted thinking and corrupted thinking leads to physical corruption, which may start as worshiping the creature over the Creator, and in its final form it leads to mongrelization. We must also point out here that mongrelization also covers gender mongrelization. This is commonly known as homosexuality which is also a corruption of God’s natural order.

The Tree of the Knowledge of Good and Evil is a representative of satanic thought that brought its insane philosophy to the Adamic race to ferment disobedience against the truth of God. Life comes from life, this is a natural law. Nothing comes from death, neither can a spiritually dead man produce a living work. The Diabolical Mentality is only capable of corruption. The biblically correct moral standard is to view everything as either a living or a dead work. This is the Christian standard.

The forbidden tree was in opposition to the justice of God. The forbidden fruit was carnal knowledge in opposition to the purity of God. Almighty God loved His chosen race and He wanted them to stay as He had created them, without mongrelization and not degenerating into an uncreated mass of mongrel peoples.

Disobedience of God’s commandments is what leads to death. Evil thoughts lead to evil actions. Paul told the Corinthians this very same thing. The enemies of God seek to draw away the Christian from justice. These enemies throw stumbling blocks out to make another barrier between you and Christ. God desires that His people be preserved from the corruption of the world. **But I fear, lest somehow as the serpent seduced Eve, in**

his craftiness, in this way, your thoughts should mongrelized away from the racial purity and the separation of the Anointed. (2 Corinthians 11.3)

The word mongrelized is translated from ἐξηπάτησεν (exepatesen) the aroist form of ἐξαπατάω (exapataó) which if you remember is defined as to deceive, seduce. The phrase “should be mongrelized” is translated from φθαρή the aroist form of φθείρω (phtheiro) defined as to destroy, to mar; to destroy, to ravage; to corrupt; to seduce; to punish by destroying; to be morally corrupted. The Liddell and Scott lexicon adds seduce a woman. Paul is warning the Corinthians that they are mongrelizing in the same way that Eve was. She was seduced first in mind which led to mongrelizing actions. Racial purity is from Ἀπλότητος (haplotētos) a form of haplotés, meaning the possibility of something happening. Defined as simplicity, sincerity, integrity, frankness; innocence. To further our understanding of this word we look at its root ἁπλός (haploos). Besides single and simplicity the definition gives us an example of being opposed to compound or mixed. Another example is given as of precious metals, unalloyed, pure. From the Liddell & Scott Greek Lexicon. The understanding of a thing being simple in the ancient world was that it was pure and with reference to persons racially pure.

The Christian can see here the racial language used to describe someone who turns from God. Eve had evil or mongrelized thoughts before she mongrelized her body. The Corinthians are scolded to remind them that if they take on another teaching besides that of Christ, their minds are corrupted and that leads to corrupted works in the flesh. The Corinthians are warned to turn back to the Mentality of Christ. This warning is significant to Christians throughout the ages. When we walk in the Separated Mentality we cannot be snatched away by evil. **And I say, walk in the Mentality, and you will not fulfill the lust of the flesh. For the flesh lusts against the Mentality, and the Mentality against the flesh, and these are contrary to one another; lest whatever you may will, these things you do. But if you are led by the Mentality, you are not under law. (Galatians 5.16-18)**

The war between the flesh and Mentality is brought out here in Galatians. This is a fundamental understanding for those entering into the Government of God. The soldier of Christ is led by the Mentality and their opposite, the godless hordes are led by their worldly lusts just as animals. In the next verses, we have the actions of the godless revealed. **Now the actions of the flesh are clearly revealed, which are: mongrelization, whoredom, impurity, raping, idol-service, pharmakeia, enmities, strife, jealousies, angers, rivalries, divisions, heresies, envyings, murders,**

drunkenness, revellings, and things like these, which I tell before, as also I said previously, that those practicing these things will not inherit the Government of God. (Galatians 5.19-21)

After the works of the flesh are shown here, which is one of many such lists in the Scriptures, the moral principles of the Separated Mentality are listed. The law shows us what is against the morality of Christ and what our duty to Christ is. Those who reject Christ are subject to the punishment of His law. **But the fruit of the Mentality is: honorable brotherly love , joy, peace, long suffering, kindness, goodness, persuasion, gentleness, self control; against such things there is no law. And those of the Anointed Jesus have crucified the flesh with the passions and the lusts. (Galatians 5.22-24)**

Enter the Government

The Government of Christ on earth is the Body Politic of Christ. The Body Politic commonly called Church, from the Greek Ekklesia is defined as an assembly (in a political sense); assembly of people. When Jesus and His students declared their gatherings as the Ekklesia, they were claiming that they were the Body Politic of the Most High God and Jesus is His Son. Why do you think they were persecuted? This was a direct insult to the Sadducees, Pharisees, and scribes, whom Jesus called a race of vipers. This claim of Christians took away their authority. It exposed the corruption of their priestcraft. The Body Politic of Christ preached the destruction of the temple in Jerusalem and the end of the Mosaic economy that made merchandise of God's people.

Jesus told his students that they are in His Government when they indwell His Mentality and live His Word. Christians are the Body Politic because they have rejected the trends and sophistries of the world. Christians follow the just judgments of Christ. Jesus was questioned about this by the religious authorities. **And being questioned by the Pharisees of when the Government of God comes, He answered them and said, 'The Government of God does not come with observation; nor will they say, 'Behold, here' or 'Behold, there;' for behold, the Government of God is within you.'** (Luke 17.20,21)

The Body Politic is a racial imperative in combination with the indwelled Mentality of Christ. The government is never geographical nor is it in a man-made building. Separated Christians are the temple of God. **Do you not know that you are a temple of God? And the Mentality of God dwells in you? If anyone mongrelizes the temple of God, God will mongrelize that one. For the temple of God is separate, which you are. (1 Corinthians 3.16,17)** The racial Church is a foundational principle in Scripture. **Then, you are aliens and refugees no more, but fellow citizens of the Separated Ones and of the household of God, having been built upon the foundation of the ambassadors and prophets, Jesus Anointed Himself being the Cornerstone, in Whom all the building fitted together grows a Separated Temple in the Master, in Whom you also are being constructed together into the place where the Mentality of God dwells. (Ephesians 2.19-22)** The Government is wherever believers are gathered. **For where two or three are gathered in My authority, there I am in their midst. (Matthew 18.29)** God does not reside in any building, He is a Mentality and He resides in His separated people who are the Living temple. **The God Who made the**

world and all things in it, this One being Master of Heaven and of earth does not dwell in handmade temples. (Acts 17.24)

The Living Temple is the Christian indwelled with the Separated Mentality of Christ. This is made known to us in the Ingesting Principle where we partake of the Word of God and thereby gain godly wisdom. The Christian holds to the principle that only God is true and every man is a liar. By way of example, judeoism is based on a false knowledge of what they think is good and a false knowledge of evil. The Judeo concept of what is evil comes about through ignorance of what is truly good. Judeos call good evil and they call evil good.

The Word of God teaches us that only God is good and that all other ways of thinking or acting are satanic. Only God is capable of Living Works. This is where the ingestion principle comes in. Only by indwelling the Separated Mentality can a man have a piece of God within him (a filled vessel). **For this reason, I bow my knees to the Father, of Whom every patriarchal family of heaven and on earth is given authority that He may give you according to the riches of His reputation to become mighty through power, through His Mentality in the inward man, that through persuasion in your hearts, having been rooted and founded in honorable brotherly love, that you may be given strength to apprehend, with all the Separated Ones, what is the breadth and length, and depth and height, to know the honorable brotherly love of the Anointed that exceeds knowledge, that you may be filled entirely to the full capacity of God. (Ephesians 3.14-19)** In this way, we are living in the Government of God while on earth. We are in the world but not of the world. **I have given them Your Word, and the world hated them because they are not of the world, as I am not of the world. I do not petition that You take them out of the world, but that You keep them from evil. They are not of the world, even as I am not of the world. (John 17.14-16)**

A Christian is justified by the Blood of Christ. We have a duty under this Blood Covenant to submit and obey the Word of God, irrespective of what the world teaches, its trends, or philosophies. When we are ruled by Christ we uphold the Divine Establishment of order as set down and separated by Christ. We have a relationship with God as it was in the beginning and is now the Christian administration of God's Government on earth. God's dealings with Adamic kind from creation till the destruction of the temple in 70 A.D. was the fulfillment of His racial covenant. This racial covenant is both spiritual and physical. The correct racial (Adamic) container must be filled with

the Separated Mentality of Christ. This is the salvation under the covenant, that when our bodies return to dust, our spirit will ascend to Christ and be at His right for eternity.

Christians are saved by persuasion in Christ. However, this persuasion is not just a belief or "blind faith". No, persuasion is a way of living that produces living works. Even the devils in Hell are said to believe in Christ, but belief is not enough. **You are persuaded that God is One. You do well; even the demons are persuaded and tremble. But are you willing to know, O vain man, that persuasion without actions is inactive? (Jacob 2.19,20)** So belief is not enough you must be persuaded. Persuasion in Christ is defined by the Bible as our confidence in the Word of God due to persuaded actions. **Now persuasion is the substance of confidence, the evidence of things not being seen. For but this the elders obtained witness. By persuasion we understand the universe to have been framed by the Word of God, so that the things seen do not come into being out of things that appear. (Hebrews 11.1-3)**

Abel offered a better sacrifice than Cain because of His persuasion, Enoch was taken up by God because of his persuasion, Noah built an ark because he was persuaded in God, Abraham offered his son for a sacrifice out of persuasion, The parents of Moses Amram and Iochabed hid their son for three months because of their persuasion, Moses refused to be under the house of the Pharo and choose God by his persuasion. **(Hebrews chapter 11)** These characters in the Scriptures are known for their persuaded acts.

There is a distinct difference between belief (as in a judeo blind faith) and a persuasion that is justified. Persuasion is the exercise of the will to obey the Word of God, it is putting belief into action. This leads us to work in the Government of God. True persuasion in Christ produces Living works. **Surely from their fruits, you will know them. (Matthew 7.20)** The one who does not produce Godly fruit is not a Christian. **So, indeed, persuasion, if it has no actions, is dead by itself. (Jacob 2.17)** The one who is not a doer of the Word of God has heard the Word but then shut it out. By hearing he was being born anew, seeing that he has a birthright to the Government of God. Then by his lust, he refuses the Word. These false Christians are spiritual traitors and they have rejected their birthright, a gift from the Most High. **And become doers of the Word and not only hearers, deceiving yourselves. Because if anyone is a hearer of the Word and not a doer, this one is like a man perceiving the face of his birth in a mirror, for he perceived himself and went away, and immediately forgot of what character he was. (Jacob 3.22-24)**

When the Mentality of God abides in an Adamic man his mind becomes renewed. This is the Baptism of Fire where the truth of Christ burns away the lies of the world. This is a resurrection, the dead mind is born from above, resurrected to truth. The mind of that man partakes in the morality of Christ. This reborn man lives as he thinks. **But one with the Mentality, truly, discerns all things, but he is discerned by no one. For who knew the mind of the Master? Who will teach him? But we have the mind of the Anointed. (1 Corinthians 2.15,16)**

The racial Church of the Anointed Nation of Jesus Christ is built on the truth of God's Word and Christian Honor. Honor is the unity of word and deed. Honor is sustained with Integrity and Loyalty. Christian Integrity is the adherence to the moral standard of Christ, undivided on its principles. These principles are understood by the lesson Christ gave us to love the Master with all our being. This is the greatest commandment which leads us to the second which is racial love. **"Teacher, which commandment is greatest in the law?" And Jesus said to him, "' You will love the Master, your God, with all your heart, and with all your life, and with all your mind.' This is the first and greatest commandment. And the second is like it, 'You will love your neighbor as yourself.' On these two commandments hang all the law and the prophets. (Matthew 22.36-40)** Christian Loyalty is devotion and obedience to the Word of God. These virtues are manifested in the racial standard of Honorable Brotherly Love. This standard is simple: love your racial neighbor and in particular love your racial Christian neighbor. **Owe no one anything, except to love one another, for he loving the other has fulfilled the law. For, "You will not mongrelize; You will not murder; You will not steal; You will not lie; You will not lust;" and if there is any other commandment, it is summed up in these words, "You will love your neighbor as yourself." Honorable brotherly love does not work evil to the neighbor; then honorable brotherly love is the fulfillment of the law. (Romans 13.8-10)**

Stepping out of the snare of sin and death we are directed along the Narrow Path to the door of Life. Come knock and Christ shall open. We then will have a share in the victory already won. Hail our Kinsman Redeemer Who defeated sin and death. **Therefore, I beseech you brothers, through the compassions of God, to present your body a living sacrifice, separated, well pleasing to God, your reasonable service. And do not be conformed to this age, but be transformed by the renewing of the mind, in order to prove by you what is the good and well pleasing and perfect will of God. (Romans 12.1,2)**
